We do not know how much or what parts of the 1979 plan will be brought forward into the June 2025 draft. It seems important to get some things right in the "Concern Areas/Elements" the June 2025 draft, no matter how "rough" or preliminary the draft will be.

State guidelines, published in late 2024, for partially planning counties, identify: Required:

- Critical areas regulations that protect critical areas normally called the Critical Areas
 Ordinance.
- 2. Natural resource lands. "Natural resource lands are agricultural, forest and mineral lands that have long-term significance for the commercial production of food, agricultural products, time, or for the extraction of minerals. All local governments must determine where natural resource industries, including forestry, agricultural, mining and fisheries industries can productively operate." Comment We do not know if county information on this is current, or on what basis these lands have been designate, or if they are mapped.

- **4.** Use of Best Available Science (in the Critical Areas Ordinance)

These and other optional elements can be separate elements in a comprehensive plan, integrated into mandatory elements or part of a subarea plan."
