Qualifications

- The applicant must have been a graduate of Trout Lake High School.
- The applicant should have a grade point average of 2.5 or greater. However, all applications will be considered.
- The applicant must be attending, or planning to attend, an accredited college, university, or vocational training program no later than October 1st of the year following the award of the scholarship. **Students who have attained a bachelor's degree, and who are pursuing a graduate degree, are not eligible.**
- If enrolled, the applicant must include a current transcript of grades & credits earned from this school/program and any prior schools (post high school). Official transcripts are preferred but unofficial transcripts are acceptable. If not currently enrolled please include transcripts from previous schooling.

Personal Statement – Include the Following Information:

Your personal statement is an expression of who you are. Be as creative as you like but make sure to cover all of the necessary information within, or in addition to, your statement.

- What are your educational goals and what are your plans for reaching these goals?
- Outline your post-secondary school academic achievements, extra-curricular activities (school related and any others), and awards, honors, and recognitions received. Please note that if you don't share this information we won't have it to consider when making scholarship decisions.
- Provide us with your employment history. Include any volunteer jobs or activities that you participated in. Indicate whether these jobs were held during the school year or were summer positions. If applicable, describe how these jobs relate to your education goals and any skills learned that will help you on your educational path.
- Where are you or where will you be attending school? Outline the costs, including tuition, housing, books & fees that you anticipate incurring. If you have not yet been accepted or have not made your school decision please let us know where you have applied and the estimated costs for each school. If you have not yet applied to school please explain why and outline your education plans.

Please detail how you have paid for your education to date and how you plan on financing the remainder of your education. Please include known financial help, from your choice of school or other sources that are available for your educational expenses.

Reference Letters

- A minimum of one letter of recommendation is required. If you have previously applied for a scholarship submit updated letter(s) of recommendation. Reference letters can be from employers, community members, teaching assistants, and professors (among others). Submitted letters must not be from an applicant's relatives.
