Re: 2020 elections for Trout Lake Community Council positions

In the fall of 2020 positions # 7, #8 and #9 on the Community Council were open for election. All three incumbents chose to run for re-election and four new candidates submitted their names for consideration. A total of 240 voters from the Trout Lake area voted. Incumbent Zack Miller was re-elected into position #7 and two new council members, Dave Wampler and Chad Thompson were elected into positions #8 and #9 respectively.

The election process was conducted in accordance to our current bylaws, approved in June 2018 which were enclosed in our notice of 2018 election letter dated January 4, 2019. I have also included a summary of the Community Council membership by position number, their respective terms, their home addresses and contact phone numbers.
