UCSB research using arrays of infrasound detectors is completed. Equipment will be removed in 2021. USGS will “design and build a fully realized detection and warning system for the long term.” Permitting process starting in 2021, installation of equipment in 2023, funds permitting, operation in 2024 also funds permitting. System will use seismographs and infrasound detectors.

Jeff King from KC emergency management expressed interest in working with USGS on the notification piece of the warning system.
