Guest Speakers

Jay McLaughlin – Gotchen Area Hazardous Fuels Work and Wildfire Preparedness Working Group Update

There has been hazardous fuels work done in the Gotchen area to prepare it for underburning, weather dependent, with the objective of reducing potential flame length and rate of spread of wildfire. They hope to start burning this Thursday. Sharon shared a powerpoint on wildfire risk in the Trout Lake area and provided information about the working group that will be trying to engage community members in becoming more prepared for wildfire. Zoom meetings will be the third Tuesday of the month and will begin in January.

7:20 Nathan Ulrich – Mt Adams Forest Phase 1 Conservation Easement Grant application

Nate is the rep for Columbia Land Trust (CLT) a conservation group focused on water, soil, habitat preservation and preservation of "working forest land". Their first phase proposal is for the purchase of a conservation easement on 6000 acres of SDS land (under pending sale agreement) west and north of Trout Lake up to the Gifford Pinchot National Forest boundary. Their intent is to purchase the development rights to the property which also includes non-motorized public access to these lands. CLT is applying for a Forest Legacy Grant from Washington State Dept of Natural Resources (WDNR) and are asking for a letter of support from the council (needed by October 14, 2021) to be included in their grant submittal. Monte moved that we write a letter of support. Pat seconded the motion. Discussion followed. Most council members voiced support for the letter,

7:50 Mendy Maccabee – Red Feather Event plans and possible Conditional Use Permit

Mendy Maccabee is the new owner of the Red Feather property. She intends to seek a conditional use permit for events and group activities other than those specifically related to agricultural use of the property and would like to hear if there are any concerns in the community. Concerns expressed by those present (local residents and council members) include: traffic, safety on roads due to increased traffic, noise associated with events that involve music, impacts to community businesses and infrastructure, changes to the quiet, rural character of Trout Lake, etc. Wendy stated that she also moved to Trout Lake for the same values expressed by residents and does not plan on her proposed activities being in conflict with those values. Concerns also were expressed regarding other properties in the Trout Lake valley where non-permitted activities are occurring and this should be something the Council needs to address in the near future.
