Laurie - The group of 4 Trout Lake residents met with the judge, On March 11th the admin records need to be submitted.

3/19 brief. 2 comment periods (one for BOCC and response from community) .

April 8th @ 1:30 hearing in Goldendale.

The case is that the BOCC dealt with redistricting in an arbitrary and capricious manner.
