Forest Legacy Conservation Easement Update and Next Steps Nate Ulrich – Columbia Land Trust (CLT)

6:07

2 years of support from council for working forest lands around TL community The goal – to purchase 45k acres of conservation easements so that forests stay intact as working forests over time.

US forest service grant program is funding land trust, DNR implements grant & negotiates with Twin Creeks Timber (managed by Green Diamond).

Other local community entities **may** be able to subdivide larger easement, will ensure public access.

Phase 2 - 14k acres along White Salmon into Skamania co - not funded last year, will reapply this year and CLT is asking for an updated letter of support from the council by the end of the month.

Timeline for future phases has moved up due to increase in program funding.

Little Mountain is eligible to be managed this way but would still be available for harvest Parcels eligible to be funded doesn't mean WILL be - it's a negotiation.

Kevin Sipe – community member – Briefing Sheet submitted, group includes Shanea Harpe, Ryan Webb, Duane Farnham, and Seth Lambert

Smart Meter awareness action program (about 40 members)

Have taken action with KPUD

Their goal to unite and educate community

Cost of meters outweigh benefits

KPUD hasn't properly informed the community

Opt out isn't an actual opt out because of cost and limitations on who can opt out.

Why? There is a global shortage of electric supply, they want/need consumers to change when and how their use electricty.

KPUD will be able to override usage. We will see rate increases

Taking existing meters and replacing them with cheaper, plastic, computerized meters which aren't as high quality and known to fail. Increased fire hazard. Meters aren't grounded, they have resistors which can fail.

Data/privacy concerns - KPUD will be able to control smart thermostats and other devices.

Safety - FCC's research was pre 1996 so not accurate.

KPUD has only tested functionality of devices, not safety

Do not want the PUD at their community meeting - they are vested and so aren't going to present a non-partial point.

Ask - will the council write a letter to support a stay on this for our community?

Laurie - address \$200 opt out fees/charges

Travis - letter to give community time to learn more

Tom - need more information

Pat - concerned about rates

Motion - Pat - letter to PUD to delay implementation of meters in order to learn more and come talk to us at a community council meeting about smart meters. 2nd - Beyyine. all in favor. Need to include that the May 2nd Community Council meeting (via Zoom) was focused on the Warner substation plans and wasn't a smart meter information meeting.

Shanea - we have tacitly consented to these meters because we've been "notified" via the Ruralite

Travis - Addend motion: to include in the letter a statement that the Community Council has not tacitly consented to the implementation of smart meters pending further information. 2nd - Beyyine, all in favor

Need anchor points
